UL wrote the Standard on safety for office furnishings systems. Since UL 1286, the Standard for Safety of Office Furnishings was introduced in 1984, customers have certified office systems, such as work surfaces, shelving and panels, to the standard to determine that products meet electrical, flammability and personal injury safety requirements.

UL 1286, the Standard for Safety of Commercial Office Furniture

UL can test and certify panels and accessories, such as work surfaces and shelving with lighting and power distributions units, and panels with no electrical connection, to the Standard. The Standard includes tests for:

- Stability and mechanical strength tests the product to help ensure safety in use
- Fire resistance evaluates materials for smoke and burn indices of particleboard, fabrics, plywood, adhesives, laminates and prefinished particleboard
- Electrical testing (if applicable) for power distribution units and lighting

Products that feature the UL Certification Mark demonstrate compliance with model installation codes and may result in faster inspections. UL is the most trusted name in safety and UL Marks are recognized by authorities for faster acceptance.

Quality Assurance and On-Site Field Evaluations

UL can help manufacturers verify quality during the manufacturing process and for finished products. UL provides on-site inspection and randomized testing at supplier locations to determine that products meet a manufacturer's specifications.

For finished products, UL provides on-site Field Evaluations for the evaluation of products already at the installation site to help address local authority concerns.

Certification Process

- Customer requests quote
- UL determines the samples and information needed for the product
- UL performs a construction review on the product to see if it complies with the standard
- UL develops data sheets and test plans
- UL develops written descriptions of products
- Customer receives a written description of the product and can use the UL Certification Mark, if the product complies.
